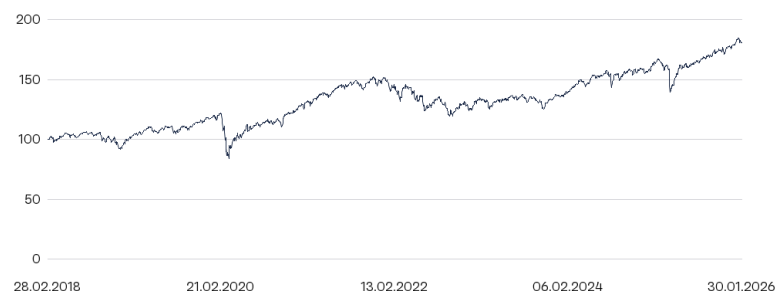
### Brief description
