Portrait

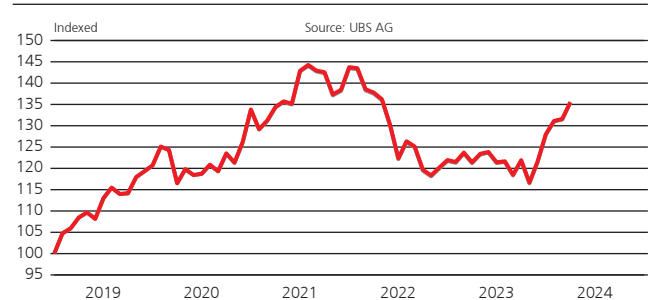
