

CSIF (CH) Bond Corporate Global ex CHF Blue ZB






Investment Policy

The fund is managed with an indexed method and is distinguished by broad diversification, low tracking errors, and low-cost management. The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The Bloomberg Global Aggregate Corporates ex CHF Index is a broad-based flagship benchmark that measures the investment grade debt. This multi-currency benchmark includes corporate bonds from both develop and emerging markets issuers.
