Investment Policy

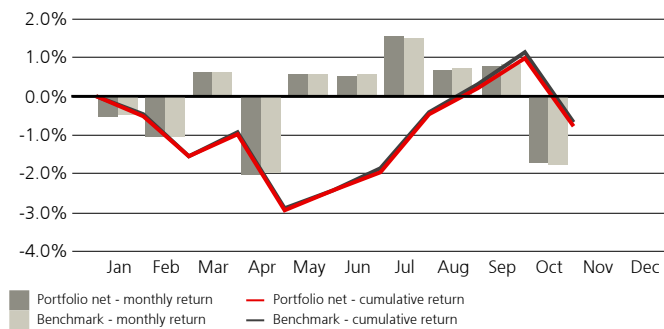
The fund is managed with an indexed method and is distinguished by broad diversification, low tracking errors, and low-cost management. The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The Bloomberg Global Aggregate ex CHF Index is a broad-based flagship benchmark that measures the investment grade debt. This multi-currency benchmark includes treasury, government-related, corporate and securitized fixed-rate bonds from both develop and emerging markets issuers.

The fund follows the exclusion recommendations of the Swiss Association for Responsible Investments (www.svk-asir.ch). The recommendations affect issuers whose conduct or products violate the normative criteria of SVK-ASIR, e.g. violations of international conventions or production of controversial weapons. This fund is not a sustainable fund and it does not integrate any environmental, social and governance (ESG) considerations into its investment process.

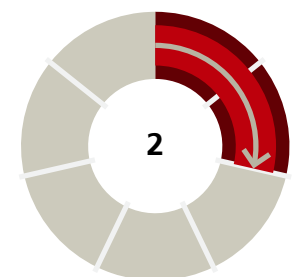

Accumulating	Indicates a regular reinvestment of the dividends received in the portfolio itself

Annualized return	A measure of how much an investment has increased on average each year during a specific period.
Beta	A measure of the volatility, or systematic risk, of a single security or fund in comparison to the market as a whole.
