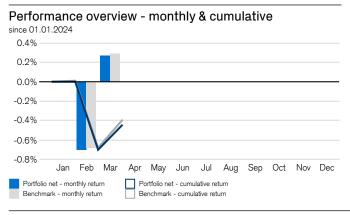

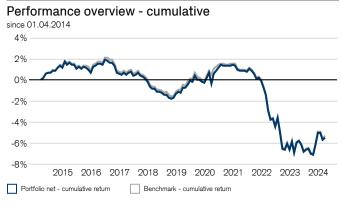
Investment Policy

The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The Bloomberg Global Aggregate ex CHF 1-5Y Index is a broad-based flagship bechmark that measures the investment grade debt. 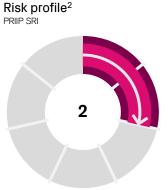
