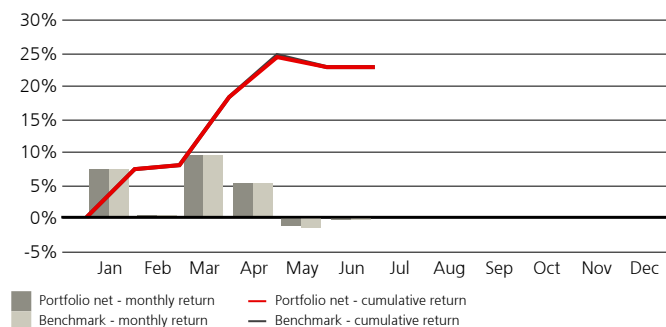
Investment Policy

The fund is managed with an indexed method and is distinguished by low tracking errors and low-cost management. The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. UBS Gold invests in physical gold (standard bars of 12.5 kg / approx. 400 ounces). All gold bars purchased are compliant with LBMA's Responsible Gold Guidance.

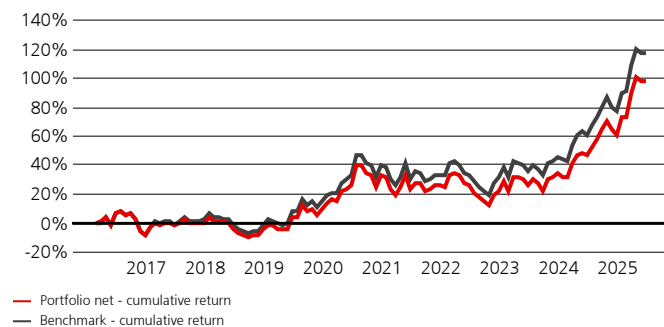
Performance overview - monthly & cumulative

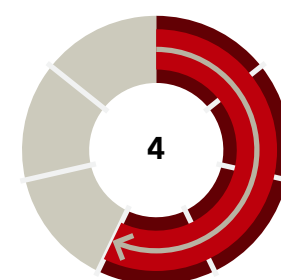
