The fund is managed with an indexed approach and is distinguished by its broad diversification, minimal tracking error, and cost-effective management. Strategy Indices deliberately deviate from market capitalization in their weighting in order to capture factor premiums or reduce the investment risk. MSCI World ex Switzerland Quality Index is a Strategy Index and seek to reflect a quality growth investment strategy by targeting stocks with historically high return on equity (ROE), stable year over year earnings growth and low financial leverage. They capture quality factors.

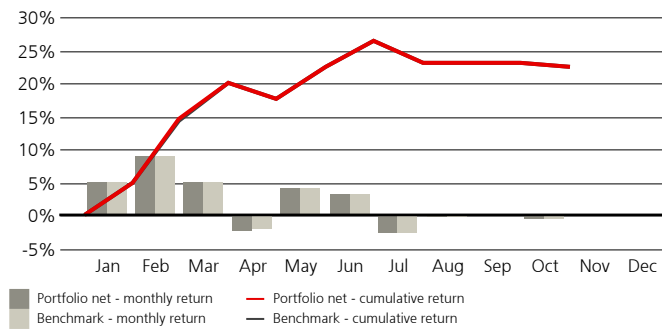

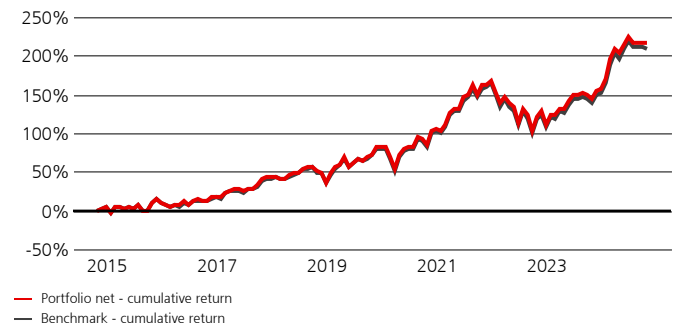
## Performance overview - monthly & cumulative
