
### **Investment Policy**

The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The MSCI World ex Switzerland ESG Leaders Index is a capitalization index that provides exposure to companies with high Environmental, Social and Governance (ESG) performance relative to their sector peers and captures large and mid-cap companies in Developed Markets countries worldwide (excluding Switzerland).



## ESG Approach<sup>3</sup>

This fund promotes environmental, social and governance (ESG) characteristics. As index tracking fund, the ESG characteristics of the fund and its ESG integration approach are derived from the ESG index that the fund is tracking. Therefore, the ESG rules and criteria applied by the fund are defined by the index provider and they may deviate from the standards set in the CSAM Sustainable Investing Policy.
