
Investment Policy

The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The MSCI USA ESG Leaders Index is a capitalization weighted index that provides exposure to companies with high Environmental, Social and Governance (ESG) performance relative to their sector peers. MSCI USA ESG Leaders Index consists of large and mid cap companies of the US market.



ESG Approach³

This fund promotes environmental, social and governance (ESG) characteristics. As index tracking fund, the ESG characteristics of the fund and its ESG integration approach are derived from the ESG index that the fund is tracking.
