- The index covers approximately 85% of the free float-adjusted market capitalization in the World ex Switzerland equity universe.

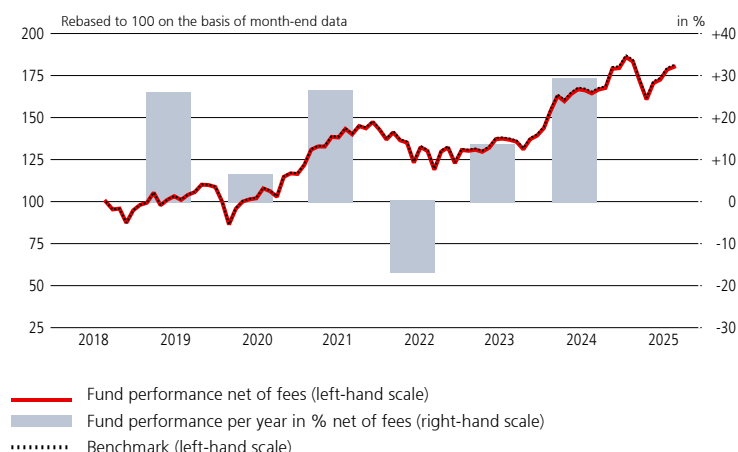
