The finpension Climate Impact 100 strategy invests 99 % in equities. The equity component is diversified worldwide based on the size of the companies' stock market valuations. Companies that attach importance to reducing emissions of climate-damaging greenhouse gases are favoured. The investment strategy is implemented passively by means of exchange-traded funds (ETFs) and index funds.
