
Brief description

The finpension Social Impact 100 strategy invests 99 % in equities. The equity component is diversified worldwide based on the size of the companies' stock market valuations. Companies that emphasise social equality between the genders, among other things, are given greater weighting. The investment strategy is implemented passively by means of exchange-traded funds (ETFs) and index funds.
